In the 1st year: unconditional on deterioration of product.

Replacement Charge - 2nd year: 60% of current dealer suggested list price. Replacement Charge - 3th year: 70% of current dealer suggested list price. Replacement Charge - 4th year: 80% of current dealer suggested list price. Replacement Charge - 5th year: 90% of current dealer suggested list price.
